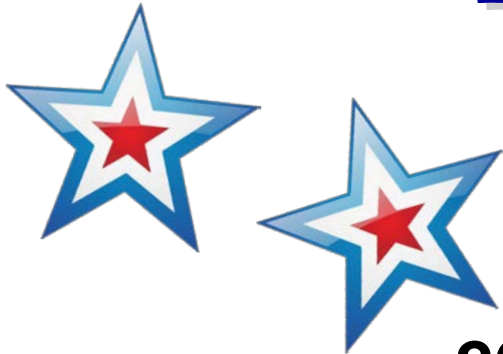

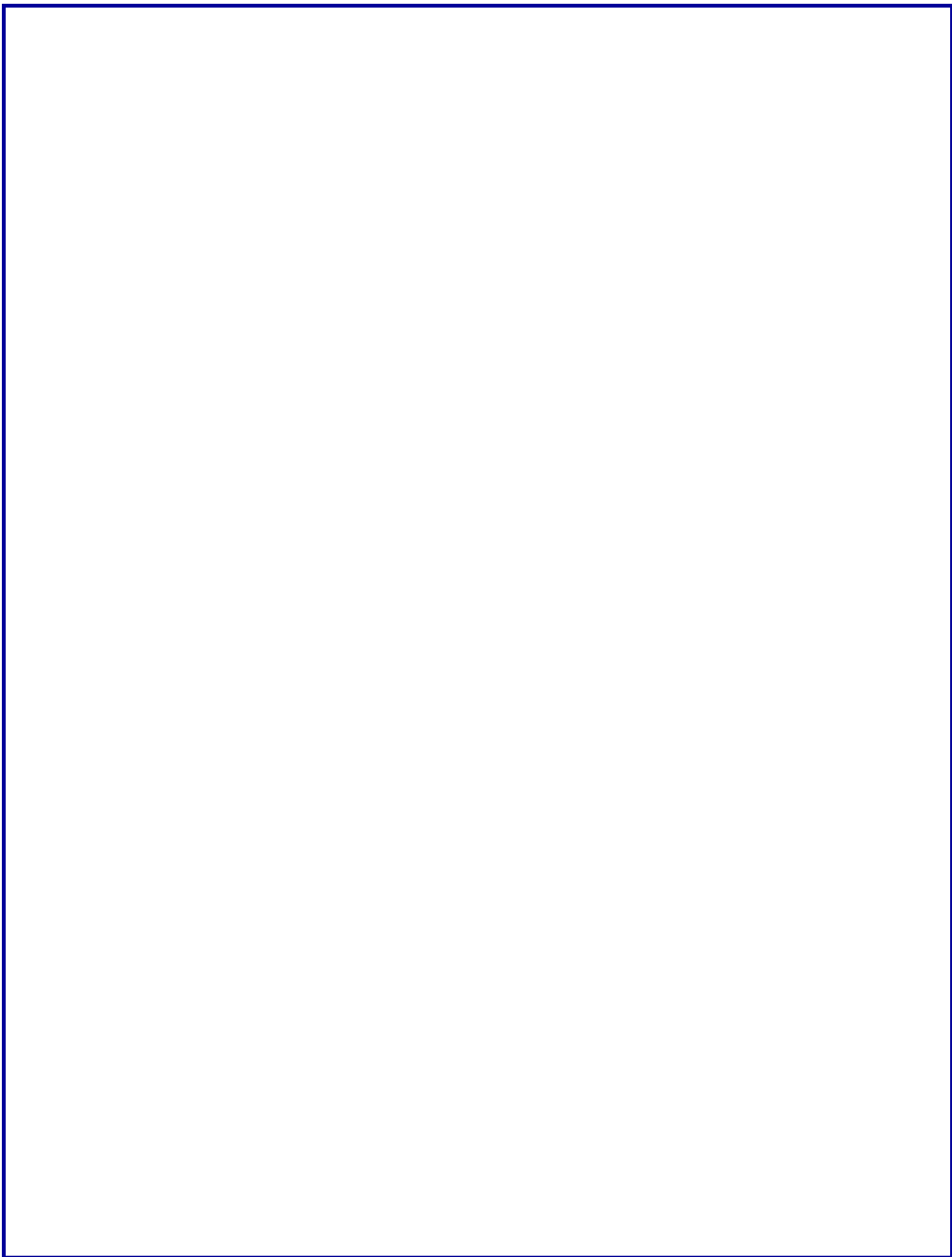

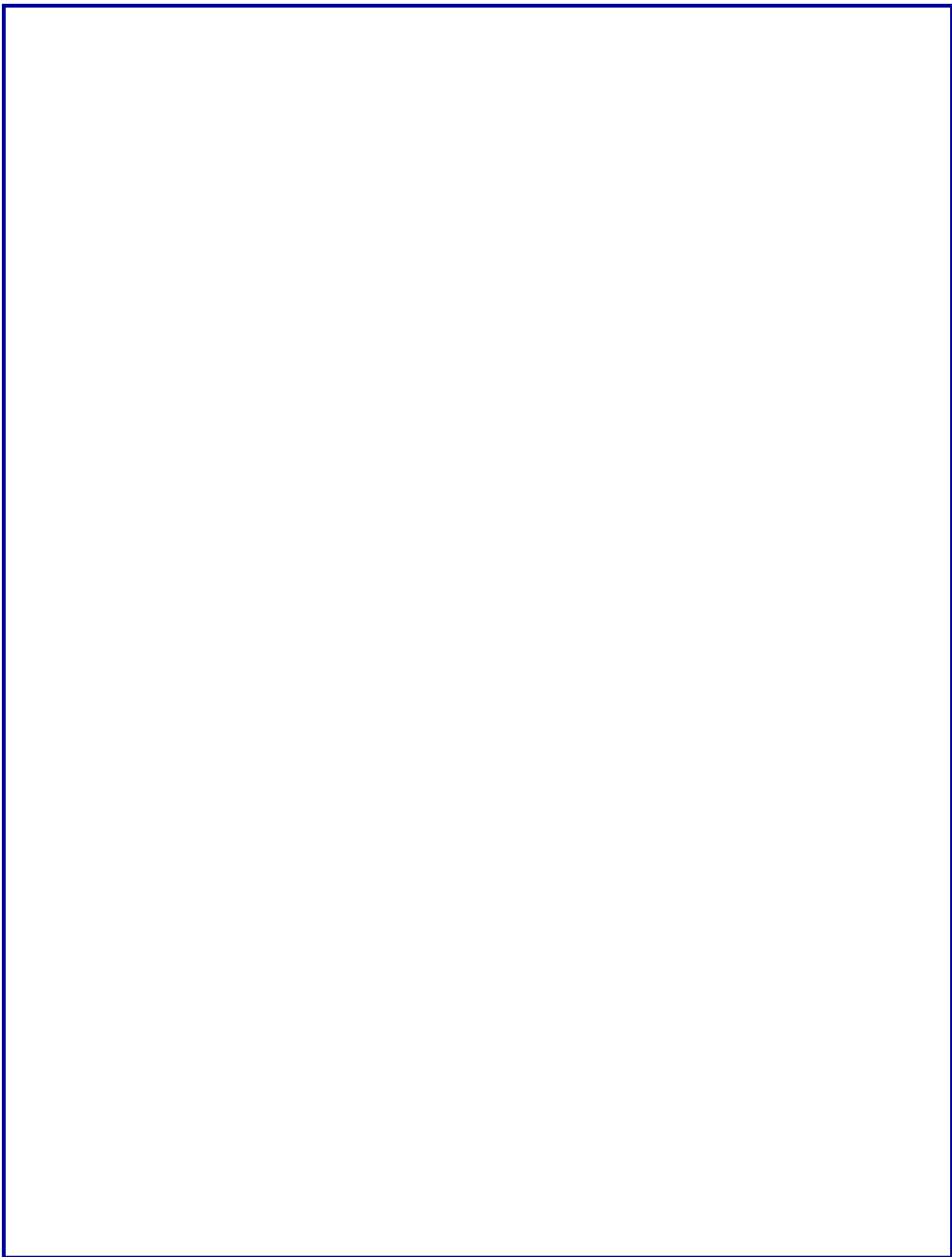

2011 DATES TO REMEMBER

- June 5 Deadline for federal, statewide, multi-county, county, and district candidates (other than judicial, state attorney, and public defender candidates) candidate to change party affiliation. (Section 99.021, F.S. – 365 days before the beginning of qualifying preceding the general election)
- October 1* Deadline by when Presidential Preference Primary Date Selection Committee meets to select the date of the Presidential Preference Primary for 2012 (Section 103.101, F.S. – Committee sets a PPP date no earlier than the 1st Tuesday in January and no later than 1st Tuesday in March in each year the number of which is multiple of 4)
- October 31 Deadline for major political parties to submit list of presidential candidates to the Secretary of State for the Presidential Preference Primary ballot (Section 103.101, F.S. – By October 31 of the year preceding the Presidential Preference Primary)
- November 2 Supervisors to notify overseas voters of upcoming 2012 Elections (Section 100.025, F.S. – At least 90 days prior to regular primary and general election)
- Last day to complete any address list maintenance program activities and to remove from the rolls “inactive” registered voters who have not voted, requested an absentee ballot or updated their voter registration records after 2 general federal elections (Section 98.065, F.S. – 90 days prior to a federal election)(Note: Voters ineligible for reasons such as felony conviction, mental incapacity, death, not a U.S. citizen, fictitious person, etc., can be removed at any time including in the 90-day period before an election)
- November 8 Secretary of State to prepare and publish list of presidential candidates and shall also notify each candidate on list (Section 103.101, F.S. – 1st Tuesday after the 1st Monday in November of the year preceding the Presidential Preference Primary)
- November 11*** Last day for delegates of presidential candidates to qualify (Section 103.101, F.S. – No later than the 2nd Friday in November preceding the Presidential Preference Primary)
- November 14 Last day for presidential candidate to have name removed from the Presidential Preference Primary ballot (Section 103.101, F.S. – Prior to the 2nd Tuesday after the 1st Monday in November preceding the Presidential Preference Primary)

- November 22 Last day for Department of State to certify the names of presidential candidates to the supervisors of elections (*Section 103.101, F.S. – No later than the 3rd Tuesday after the 1st Monday in November of the year preceding the Presidential Preference Primary*)
- December 2 Date by when state executive committee must adopt by rule the number and procedures for selection of delegates (*Section 103.101(5), F.S. – At least 60 days before presidential preference primary election*)
- December 7 Revisions to security procedures due to the Department of State (*Section 101.015, F.S. and Rule 1S-2.015, F.A.C – At least 45 days before early voting begins*)
- December 9 Last date by when state executive committee may file with the Department party rule regarding number and procedures for selection of delegates assuming it adopted the rule on December 2nd (*Section 103.101(5), F.S. – At least 7 days after adoption of party rule*)
- December 17* Deadline for supervisor to mail absentee ballots to absent stateside and overseas uniformed services voters and overseas civilian voters for the Presidential Preference Primary (*Section 101.62, F.S. – At least 45 days prior to each presidential preference primary election, primary election, and general election*)
- December 27 - January 3 Mandated time period to mail absentee ballots to all absentee voters other than UOCAVA voters (*Section 101.62, F.S. –Between the 35th and 28th day before presidential preference primary election*)

2012 DATES TO REMEMBER

- January 1*** Last day for supervisors to designate early voting sites and to provide the Division addresses and early voting hours for the Presidential Preference Primary (*Section 101.657, F.S. – No later than the 30th day before an Election*)
- First day a challenge to a voter may be filed for the Presidential Preference Primary (*Section 101.111, F.S. – No sooner than 30 days before an election*)
- January 3 Voter registration closes for the Presidential Preference Primary (*Section 97.055, F.S. – On the 29th day before each election. If the 29th day falls on a Saturday, Sunday, or legal holiday, the deadline is the next that is not a Sunday or legal holiday*)
- January 6 Last day for supervisors to mail notice of time and location of logic and accuracy test to county party chairs and candidates who did not receive notice at qualifying (*Section 101.5612, F.S. – At least 15 days prior to the beginning of early voting*)
- January 7* Poll watcher designations due for early voting sites for Presidential Preference Primary (*Section 101.131, F.S. – Before noon, at least 14 days before early voting begins*)
- January 10 Legislative Session begins (*Section 1, Chapter 2010-91, Laws of Florida, provide that, “in accordance with subsection (b) of Section 3 of Article III of the State Constitution and in lieu of the date fixed therein, the 2012 Regular Session of the Legislature shall convene on January 10, 2012.”*)
- January 11 Last day for supervisors to appoint poll workers for the Presidential Preference Primary (*Section 102.012, F.S. – At least 20 days before each election*)
- January 14* Last day for supervisors to approve poll watchers for early voting sites for the Presidential Preference Primary (*Section 101.131, F.S. – No later than 7 days before early voting begins*)
- Deadline for supervisors to provide identification badges to designated poll watchers (*Section 101.131, F.S. –at least 7 days before early voting begins*)

- January 17 Noon, poll watcher designations for the Presidential Preference Primary due (*Section 101.131, F.S. – Prior to noon of the 2nd Tuesday preceding the election*)
- January 21* Early voting begins for Presidential Preference Primary (*Section 101.657, F.S. – On the 10th day before an election*)
- January 22** First day for supervisors to prepare daily electronic files of early voting summary and early voting details and upload to the Department of State (*Section 101.657, F.S. – No later than noon of each day for the previous day's activities*)
- January 24 Last day for supervisors to approve poll watchers for the Presidential Preference Primary (*Section 101.131, F.S. – On or before the Tuesday before the election*)
- Last day for supervisors to mail sample ballots to voters in lieu of publication for the Presidential Preference Primary (*Section 101.20, F.S. – At least 7 days prior to an election*)
- January 25 5 p.m., deadline for supervisors to receive requests to mail absentee ballots to voters for the Presidential Preference Primary (*Section 101.62, F.S. – No later than 5 p.m. on the 6th day before the election*)
- January 26 First day to provide absentee ballots to designees for the Presidential Preference Primary (*Section 101.62, F.S. – Up to 5 days prior to the election*)
- January 27 Last day for supervisors to mail absentee ballots for the Presidential Preference Primary (*Section 101.62, F.S. – No later than 4 days before the election*)
- 5 p.m., deadline for late registration for individuals covered by the Uniformed and Overseas Absentee Voting Act (UOCAVA) (*Section 97.0555, F.S. and Rule 1S-2.029, F.A.C – 5 p.m. on the Friday before the election*)

- † Early voting ends for the Presidential Preference Primary (*Section 101.657, F.S. – On the 2nd day before an election*)
- January 30 Last day to publish sample ballot in newspaper of general circulation in the county for the Presidential Preference Primary (*Section 101.20, F.S. – Prior to the day of the election*)
- January 31 PRESIDENTIAL PREFERENCE PRIMARY (*Section 103.101, F.S. – On the last Tuesday in January of each year that is a multiple of 4*)
- 7 p.m., deadline for receipt of absentee ballots for the Presidential Preference Primary (except for votes cast for federal office on overseas absentee ballots which are postmarked or signed and dated no later than the date of the election and received no later than 10 days from the date of the election) – (*Rule 1S-2.013, F.A.C, based on settlement agreement: United States vs. State of Florida et al., TCA-80-1055 [N.D. Fla. Apr. 2, 1982]*)
- Preliminary election returns must be filed with the Department of State, beginning within 30 minutes after polls close and in 45-minute increments thereafter until all results (except provisional ballots) are completely reported. (*Section 102.141, F.S.. on election night*)
- Supervisors to certify list maintenance activities to the Division (*Sections 98.065 and 98.075, F.S. – No later than January 31 of each year*)
- February 1 Initiative petition signature certification deadline (*Article XI, Section 5, Fla. Const. – No later than February 1 of the general election year*)
- February 2 5 p.m., deadline for persons voting a provisional ballot to provide evidence of eligibility to supervisors (*Section 101.048, F.S. – No later than 5 p.m. on the 2nd day following the election*)
- February 4* Noon, deadline for county canvassing board to file 1st unofficial results of Presidential Preference Primary with the Department of State (*Section 102.141, F.S. – No later than noon of the 4th day after a general or other election*)

- February 10 Deadline for receipt of overseas ballots for Presidential Preference Primary (*Rule 1S-2.013, F.A.C. – Ballot postmarked or signed and dated no later than the date of the federal election and received no later than 10 days from the date of the election*)
- February 12** Noon, deadline for county canvassing board official certificates to be filed with the Department of State for the Presidential Preference Primary (*Section 102.112, F.S. – Noon on the 12th day following the election*)
- February 12** County canvassing board to file a report with the Division of Elections on the conduct of the Presidential Preference Primary (*Section 102.141, F.S. – At the same time that the results of an election are certified*)
- February 13 County canvassing boards to begin manual audit of the voting system for the Presidential Preference Primary (*Section 101.591, F.S. and Rule 1S-5.026, F.A.C, - Immediately following the certification of the Election by the county canvassing board*)
- February 14 9 a.m., Election Canvassing Commission meets to certify the returns for the Presidential Preference Primary(*Section 102.111, F.S. – 9 a.m. on the 14th day after the General Election*)
- February 19** 11:59 p.m., deadline for completion of the manual audit and for results to be made public (*Section 101.591, F.S., - No later than 11:59 p.m. on the 7th day following certification of the Election by the county canvassing board*)
- March 1 Deadline by which provisional ballot information must be made available on free access system for the Presidential Preference Primary (*Section 101.048, F.S. – No later than 30 days following the election*)
- March 5 Report of manual audit due to Division of Elections (*Section 101.591, F.S. and Rule 1S-5.026, F.A.C, – Within 15 days after completion of the audit*)

- Deadline for supervisors to update voter history for Presidential Preference Primary Election (*Section 98.0981, F.S.– Within 30 days after certification of election results for election*)
- March 17* Department of State to publish notice of general election in a newspaper of general circulation in each county twice before April 16 (*Section 100.021, F.S. – During the 30 days prior to the beginning of qualifying*)
- March 19 Noon, petitions for judicial, state attorney and public defender candidates seeking to qualify by the petition method due to supervisors (*Sections 99.095 and 105.035, F.S. – Before noon of the 28th day preceding the 1st day of the qualifying period for the office sought*)
- March 30 Deadline for Department to report on compilation of precinct level results of the Presidential Preference Primary Election and updated voter history (*Section 98.0981, F.S.– Within 45 days after certification of election results for Presidential Preference Primary Election*)
- April 2 Qualifying offices may begin accepting and holding qualifying papers for judicial, state attorney and public defender candidates to be processed and filed during the qualifying period (*Sections 99.061 and 105.031, F.S. – No earlier than 14 days prior to the beginning of the qualifying period*)
- April 6 Written resignations due for officers qualifying as judicial, state attorney or public defender candidates if the terms of the offices, or any part thereof, run concurrently with each other (*Section 99.012, F.S. – At least 10 days prior to the first day of the qualifying period*)
- April 9 Deadline for supervisors to certify to the Division the number of valid signatures for judicial, state attorney and public defender candidates seeking to qualify by the petition method (*Sections 99.095 and 105.035, F.S. – No later than the 7th day before the 1st day of the qualifying period*)

- April 27 Deadline for Department of State to certify to the supervisors the names of all duly qualified judicial, state attorney and public defender candidates who have qualified with the Department (*Section 99.061, F.S. – Within 7 days after the closing date for qualifying*)
- May 7 Noon, petitions for federal, statewide, multi-county, county and district candidates seeking to qualify by the petition method due to supervisors (*Section 99.095, F.S. – Before noon of the 28th day preceding the 1st day of the qualifying period for the office sought*)
- May 10 First day state write-in absentee ballots made available to overseas voters (*Section 101.6951, F.S. – 180 days prior to the General Election*)
- Department of State to remit to the respective state executive committees of political parties, 95% of their entitled filing fees and party assessments from state attorney and public defender candidates (*Section 99.103, F.S. – No later than 20 days after the close of qualifying*)
- May 16 Deadline for supervisors to notify overseas voters of upcoming primary and general elections (*Section 100.025, F.S. – At least 90 days prior to regular primary and general elections*)
- Last day to complete any address list maintenance program activities and to remove from the rolls registered voters who are designated as “inactive” because of an undeliverable address confirmation notice or never responded to such notice and who have thereafter not voted, requested an absentee ballot, or updated their voter registration records after 2 general federal elections (*Section 98.065, F.S. – 90 days prior to a federal election*)(*Note: Voters ineligible for reasons such as felony conviction, mental incapacity, death, not a U.S. citizen, fictitious person, etc., can be removed at any time including in the 90-day period before an election*)
- May 21 Qualifying offices may begin accepting and holding qualifying papers for federal, statewide, multi-county, county and district candidates to be processed and filed during the qualifying period (*Section 99.061, F.S. – No earlier than 14 days prior to the beginning of the qualifying period*)

- May 28 Deadline for supervisors to certify to the Division the number of valid signatures for federal, statewide, multi-county, and district candidates seeking to qualify by the petition method (*Section 99.095, F.S. – No later than the 7th day before the first day of the qualifying period*)
- June 4 Noon, qualifying **begins** for all federal, statewide, multi-county, county, and district candidates (other than judicial, state attorney, and public defender candidates)(*Section 99.061, F.S. – Noon of the 71st day prior to the primary election*)
- June 8 Noon, qualifying **ends** for all federal, statewide, multi-county, county, and district candidates (other than, judicial, state attorney, and public defender candidates)(*Section 99.061, F.S. – No later than noon of the 67th day prior to the primary election*)
- June 9* Supervisors to submit to the Department a list containing the names, party affiliations, and addresses of all candidates and the offices for which they qualified (*Section 99.092, F.S. – Immediately after the last day for qualifying*)
- June 15 Supervisors to prepare daily electronic files of absentee ballot request information and upload to the Department of State for the Primary Election (*Section 101.62, F.S. and Rule 1S-2.043, F.A.C. – 60 days prior to the primary on a daily basis by 8 a.m. until 15 days after the general election*)
- Deadline for Department of State to certify to the supervisors the names of all duly qualified federal, statewide, multicounty, and district candidates who have qualified with the Department (*Section 99.061, F.S. – Within 7 days after the closing date for qualifying*)
- June 18 First day for write-in candidates for President and Vice President to qualify (*Section 103.022, F.S. – After the 57th day prior to the primary election*)
- June 20 Revisions to Security procedures due to the Department of State (*Section 101.015, F.S. – At least 45 days before early voting begins*)

- June 30* Deadline for supervisors to mail absentee ballots to UOCAVA voters for the Primary Election (*Section 101.62, F.S. – No fewer than 45 days before the primary election*)
- July 8** Supervisor to remit filing fees to the state executive committee of the political party of the candidates (*Section 99.061, F.S. – Within 30 days after the close of qualifying*)
- July 10 – July 17 Mandated period in which to send out absentee ballots to all non-UOCAVA absentee voters (*Section 101.62, F.S. – Between 35th and 28th day before the election*)
- July 15** Deadline for petitions for Presidential candidates with no party affiliation or minor party affiliated (with no national party) to be filed with the Supervisor of Elections (*Section 103.021, F.S. – No later than July 15 of each presidential election year*)
- Last day for supervisors to designate early voting sites for the Primary Election and to notify the Division of Elections of addresses and hours for each site (*Section 101.657, F.S. – No later than the 30th day prior to the election*)
- First day a challenge to a voter may be filed for the Primary Election (*Section 101.111, F.S. – No sooner than 30 days before an election*)

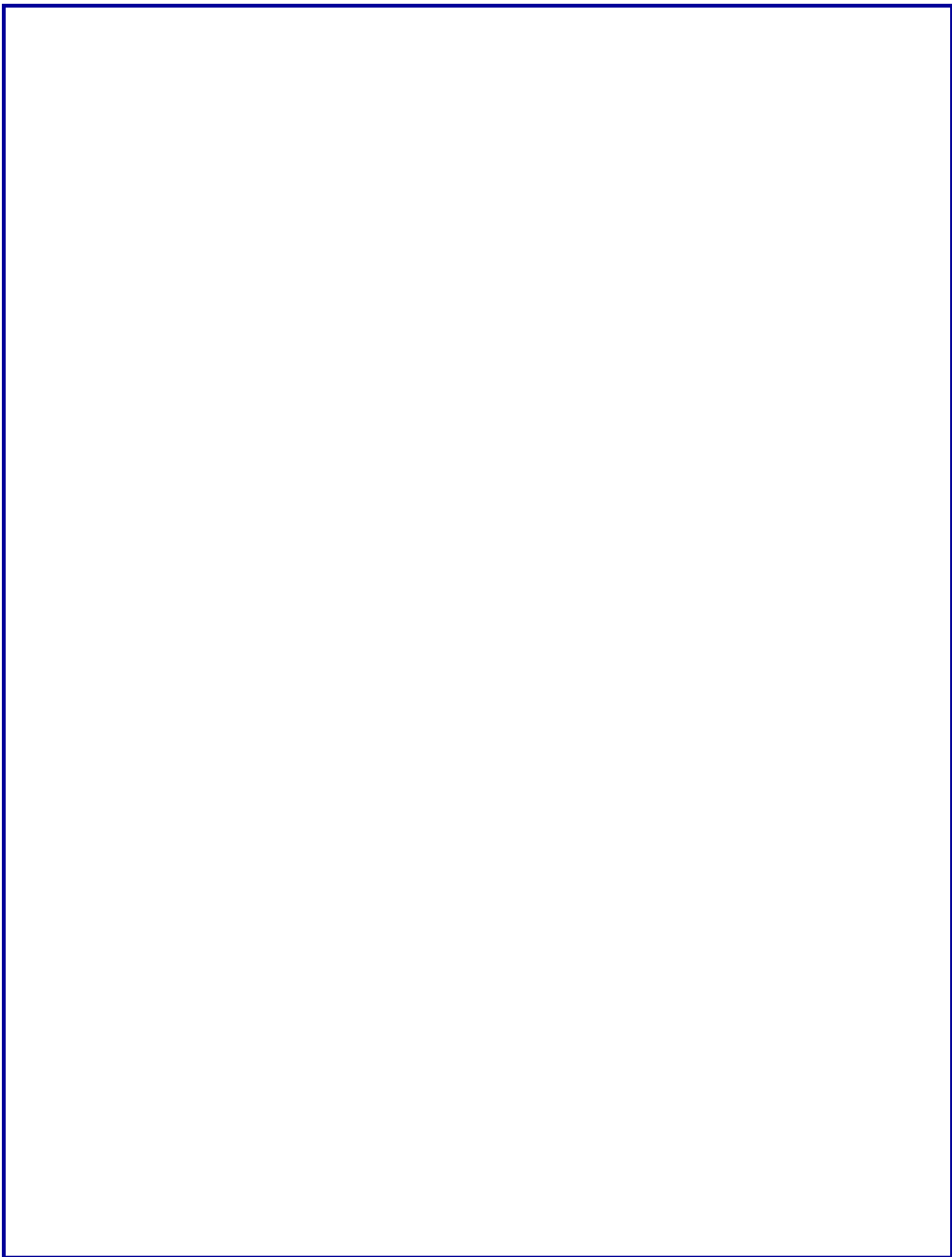
